A. Work Session on SAU #2 Proposed 2019-2020 Budget

The proposed SAU #2 2019 – 2020 Budget was discussed. Mrs. Moriarty, Superintendent, explained that rather than presenting a “salary pool”, dollar increases for each position are being proposed. It was suggested that line 12 be removed as it is blank because a salary pool is not being proposed. Mrs. Moriarty shared that the column “Adopted 2018/2019 Column” reflects actual amounts, which needs to be considered when reviewing particularly the Accounting and Business Specialist line, as this position was hired after the start of the year and therefore, the dollar increase appears greater. Additionally, Mrs. Moriarty noted, as shared last spring, the New Hampshire Retirement System requires that the Director of Student Services fall under the teacher retirement versus employee. Concerns regarding rising costs and decreasing enrollments were shared.

Mr. Hanson moved, seconded by Mr. Baker to move the proposed budget to the December 18, 2018 SAU #2 Budget Public Hearing. The motion passed unanimously.
